1. "Evaluation of Legislation", Warsaw, June 15<sup>th</sup> and 16<sup>th</sup>, 2000

The Fourth Congress of the EAL will be held on June 15<sup>th</sup> and 16<sup>th</sup> under the topic of "Evaluation of Legislation" in the premises of the Sejm of the Republic of Poland in Warsaw.

There will be four half-day sessions with 14 reports on issues related to the main topic delivered by speakers from the hosting country, European countries and Northern America.

#### 2. Further Activities

#### a. Recent Activities

In Newsletter No. 10 of August 1999 we reported on the activities of some of our new members and our Canadian friend, Robert C. Bergeron, in developing and strengthening legislative expertise Ukraine. Among the results is the Center for Legal Reform and Legislative Drafting with the Ministry of Justice of Ukraine which was established by two Decrees of the President of Ukraine in April / November 1994. The main aim of the Center's activity is to organise the studies of the legislative drafters on the level of the executive power. Desiring to obtain this objective, in the Center "School for legislative drafting" is functioning, purpose of which is to create conditions for improvement of the legislative level of Ukraine. In the same time the Center takes care of providing with the informational and methodological materials concerning the foreign legislation that could help the legislative drafters in work. Methodological manuals that include legislative technique texts by the foreign and native authors are also being created in the center.

The **School of Legislative Drafting**, established under the control of the Ministry of Justice of Ukraine and the Ukrainian Assembly for Legal Reforms on March 30<sup>th</sup>, 1999 is one of its kind in the former soviet states. The study course, which is the result of a solid gathering and elaboration of the materials of foreign experience and home acquisitions, is being

laid out according to the developed programme approved by the Ministry of Justice of Ukraine. The School's aim is to gain practical habits in drafting technique and implanting of modern methods in preparing normative legal acts.
