In honour of our member Heinz Schaeffer, who turned 60 this year, the University of Salzburg, Austria, Law School organised an international symposion on "Verfassung in Zeiten des Wandels (Constitution in Times of Change – Democracy, Federalism, Rule of Law)" on April 26th and 27th, 2001. Among the speakers were Prof. Dr. Josef Isensee of the University of Bonn and Prof. Dr. Jaume Vernet i Llobet of the University of Tarragona. The conference covered topics such as the future of Austrian federalism within the EU and the rule of law in the EU.

On June 10 – 12, a European Law Conference, hosted by the Swedish Parliament and Government, took place in Stockholm. The conference dealt in particular with EC law issues, such as The future role and function of the EC Court, women's equality, Consumer Law, The European Parliament and the national parliaments' influence in the legislative process and fundamental rights. It was led by Gunnar Grenfors, former Secretary-General of Parliament, as chairman. On September 13th – 15th, 2001, the First European Jurists Forum (Europäischer Juristentag) took place in Nuremberg, Germany. Many members of the EAL gathered around the conference and – besides other things discussed – the Fifth EAL Congress is to take place in Athens in May or June 2002.

The EJF was split in three working groups, dealing with the citizen in the Union, corporate activity in the community, judicial cooperation in the Union.

The European Association of Legislation is in permanent contact with the European Law Students' Association (ELSA). The association was founded in Vienna, Austria in 1981. Its aim is to strengthen legal cooperation between law students and young lawyers from different European countries. In 20 years of its existence, ELSA has become an international association representing 41 national association with 30,000 members in 180 (Western / Eastern) European cities. As an NGO, it has gained consultative status to the Economic and Social Council of the United Nations (ECOSOC). ELSA activities can be divided into three major ("key") areas: S&C (Seminars and Conferences), AA (local Academic Activities) and STEP (Student Trainee Exchange Programme). a. EAL

The EAL publications series now covers **five** publications:

No. 1 – "Legislation in European Countries". Various European Countries are preparing for membership of the European Union and are therefore stepping up their activities in the field of comparative legal studies. A conference held in Germany in 1991 was devoted to this and other legislative problems and was attended by experts from 25 countries and they included members of parliament, government officials,

No. 2 – "Contributions to the Methodology of the Creation of Written Law": One of the most pressing problems faced by Europe's legislators today is the question of how to draft precise and yet intelligible law texts, thus reducing the proliferation of law and improving its quality. During the First Congress of the EAL in Liège in 1993 ten authors deal with the different steps of the legislative process: from defining the norm content, drafting the norm and enforcing it to the evaluation of the effectiveness and efficiency of the law. No. 3 is the Liège (No. 2) publication in Russian language.

No. 4 – "National Legislation in the European Framework" – featuring the results of the Rome Congress in 1995.

No. 5 – "Role and Function of the Second Chamber": Report of the third conference of the EAL held in Munich 1997.

No. 6 – "Evaluation of Legislation": Report on the proceedings of the Fourth Congress of the EAL in Warsaw, 2000 (currently being edited and expected to be available by the end of 2001).

The chairman and members St John N Bates, Luzius Mader are still involved in a Council of Europe project aiming at training members of parliaments and administrators of ministries in matters of techniques of legislation. After training courses in Tbilisi (Georgia) and Kyiv (Ukraine) as well as Tirana, Albania in late 2000 and 2001. The group is on its way to Belgrade, Yugoslavia, and Moscow, Russia.

5. Varia

The Fifth Congress of the EAL to be held in 2002 will be hosted by the European Public Law Center in Athens, Greece, and its chairman, Prof. Spyridon Flogaitis. Ulrich Karpen is going to travel to Athens in December, 2001 to prepare the Congress. If there are any suggestions as for the topic, please let the board know.
