# 1. Seventh Congress of the EAL, The Hague, Netherlands

The Seventh Congress of the European Association of Legislation

The Academy for Legislation announces the Seventh Congress of the European Association of Legislation as follows:

Following the successful 6<sup>th</sup> EAL-Congress in Bern, Switzerland, the Academy of Legislation and the Centre of Expertise on Legislation of the Dutch Ministry of Justice, are happy to announce, that the 7<sup>th</sup> Congress of The European Association of Legislation (EAL) 2006 will be held on 31st May, 1st June in The Hague, Netherlands.

In most European states, the strive for continuous improvement of the quality of legislation coincides with a growing concern and attention for the education and training of legislative lawyers. A basic question relates to

what legal drafters need to know in different stages of their career, in order to carry out their work successfully. It refers equally to the scope and shape of the *education permanente* for this craft. These topics and others will be enclosed by the theme 'The Learning Legislator'.

The programme for the 2-day event has a draft status: the secretariat is still in the process of approaching keynote speakers and establishing sub themes in more detail. By mid December we will be able to disclose more information about the upcoming event on the Congress website (www.eal2006.org).

Furthermore, we intend to make an inventory of the European institutes and organisations, which are concerned with education and research in the field of 'legislation'.
